A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS STATE UNIVERSITY IN THE ENHANCEMENT OF DAMILI INDUSTRY AND PRODUCTS WHICH WILL BE IMPLEMENTED BY THE COLLEGE OF ENGINEERING, COLLEGE OF INDUSTRIAL TECHNOLOGY, AND OTHER RELATED COLLEGES.

WHEREAS, the LGU shall foster the preservation, enrichment and dynamic evolution of San Nicoleños' culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression;

WHEREAS, Damili-making, known to be the municipality's centuries-old industry, has been contributing for the sustainable development of the municipality especially in the lives of thousands of San Nicoleños and Ilocanos, thus, one of the most revered industries in the country;

WHEREAS, in the book, "Agdamdamili" accounts the history and growth of earthenware (Damili) in the municipality "The discovery of plastic clay by a Friar during the Spanish regime led to the introduction of "alfareria" or art of the potter in San Nicolas. Fray Valentin Marin's writings on San Nicolas mentioned of the establishment of pottery in the town in this manner: "A un antigo parroco Agustino se debe la introduction de la industria alfareria". It was cited in the dominician's book titled "ENSAYO, 1899". In the distant years, there existed the name "alfareria". Barangay 8 was called "Alfareria" before it was named San Rufino because it was the pilot center of pottery. San Nicoleños from other barangays which include 6, 7, 9, 23 and 24 underwent pottery training, thus, the growth of the industry.

WHEREAS, over the years, Damili has become the source of identity, pride, and inspiration of the municipality and its people;

WHEREAS, the project titled, "IMPROVEMENT OF DAMILI PRODUCTION AND MARKETING" intends to preserve, promote, and improve the damili products with research component;

WHEREAS, Section 444 of the Local Government Code of 1991 requires prior authorization from the Sangguniang Bayan before the Local Chief Executive can effectively execute or sign documents for and on behalf of the municipality, to wit:

(vi) Upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;
