“RESOLUTION NO. 2017-175

A RESOLUTION APPROVING THE ALIGNED LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) OF SAN NICOLAS, ILOCOS NORTE FOR CALENDAR YEAR 2017-2022 AS EMBODIED IN THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2017-04.

WHEREAS, the DILG provided guidelines for strengthening linkage of National/Regional/Provincial Development Strategies, Programs, Projects and Activities (PPA) with the Comprehensive Development Program (CDP) thru Memorandum Circular No. 2017-84 dated June 29, 2017;

WHEREAS, DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 Series of 2016 (JMC No. 2016-01) contains the “Updated Circular on the Harmonization of Local Planning, Investment Programming, Resource Mobilization, Budgeting, Expenditures Management and Performance Monitoring and Coordination in Financial Oversight dated November 18, 2016;

WHEREAS, NEDA-DILG-DBM-DOF Joint Memorandum Circular No. 01 Series of 2007 (JMC 2007-01) provides that National Plans should be dovetailed with Local Development Plans;

WHEREAS, the DILG conduct the Provincial Strategic Directions Setting Conference Workshop for the LGUs to come up with the aligned Local Development Investment Program (LDIP) for Calendar Year 2017-2022;

WHEREAS, the municipality has an existing Local Development Investment Program (LDIP) for 2014-2019 embodied in the Comprehensive Development Plan duly approved by the Sangguniang Bayan on July 7, 2014;

WHEREAS, after a thorough study of the Committee on Finance, Budget and Appropriations and the Committee on Laws, Rules, Ethics, Privileges and Good Government, it was found out that said projects were identified to conform to the alignment in the DILG Memorandum Circular 2017-84;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION, to approve the Aligned Local Development Investment Program (LDIP) of San Nicolas, Ilocos Norte for Calendar Year 2017-2022 as embodied in the Municipal Development Council Resolution No. 2017-04., copy of the same is hereto attached;

WHEREFORE, on motion of Member Norberto S. Dadiz, Jr., duly seconded, the foregoing resolution was unanimously approved.




