A RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE FOR CALENDAR YEAR 2017 AS EMBODIED IN THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2017-06.

WHEREAS, San Nicolas is a recipient of Agrarian Reform Infrastructure Support Program and Bridge Program of the National Government;

WHEREAS, Barangay San Agustin is a recipient of the "Tulay ng Pangulo Program" and the LGU is required to allocate funds as counterpart for the demolition, road widening and relocation of INEC primary lines and restoration of existing potable water system pipelines;

WHEREAS, one of the ARISP project implemented in Barangay 22 is the Construction of Cooperative Warehouse/Bodega which is now needing repairs;

WHEREAS, after a thorough study of the Committee on Finance, Budget and Appropriations and the Committee on Laws, Rules, Ethics, Privileges and Good Government, it was found out that the same is in order;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION, to approve the Supplemental Annual Investment Program of the Municipality of San Nicolas, Ilocos Norte for Calendar Year 2017 as embodied in the Municipal Development Council Resolution No. 2017-06, copy of the same is hereto attached;
