“RESOLUTION NO. 2017-177

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER FOR AND IN BEHALF OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) ON THE IMPLEMENTATION OF GENDER-RESPONSIVE CASE MANAGEMENT.

WHEREAS, duly submitted to this August body is a Draft Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) on the implementation of Gender-Responsive Case Management (GRCM) as a measure to ensure healing and recovery of victim-survivors and to capacitate social workers as case managers in handling violence against women (VAW) cases;

WHEREAS, for the partnership to be put into fruition, it is necessary for the municipal government to enter into such Memorandum of Agreement (MOA) through the able representation of the incumbent Municipal Mayor;

WHEREAS, Section 444 of the Local Government Code of 1991 requires prior authorization from the Sangguniang Bayan before the Local Chief Executive can effectively execute or sign documents for and on behalf of the municipality, to wit:

(vi) Upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, after thorough study and deliberation, the Sangguniang Bayan deems it necessary and proper to approve this resolution;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION to authorize the Local Chief Executive to enter for and in behalf of the Municipality of San Nicolas, Ilocos Norte, to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) on the Implementation of Gender-Responsive Case Management.

RESOLVED, FURTHER, to furnish copy of this Resolution to all concerned, for their information and guidance.


