“RESOLUTION NO. 2017-178

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A
MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND
DEVELOPMENT FIELD OFFICE I FOR THE IMPLEMENTATION OF THE PANTAWID
PAMILYANG PILIPINO PROGRAM.**

WHEREAS, DSWD, envisions all Filipinos free from hunger and poverty, have equal access to opportunities, enabled by a fair, just and peaceful society, and takes protection of the poor and marginalized memberse of society as its main mission as “ Social Protection”;

WHEREAS, in pursuit of this visio and to operationalize its Social Protection mission, the Department adopts a “Whole of DSWD” approach in ensuring convergence in the implementation of the department’s various strategies, programs, projects, and activities, otherwise known as “PPAs”, to address the needs of the poor.

WHEREAS, Section 444 of the Local Government Code of 1991 requires prior authorization from the Sangguniang Bayan before the Local Chief Executive can effectively execute or sign documents for and on behalf of the municipality, to wit:

(vi) Upon authorization by the Sangguniang Bayn, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, after thorough study and deliberation, the Sangguniang Bayan deems it necessary and proper to approve this resolution;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the Department of Social Welfare and Development Field Office I for the implementation of the Pantawid Pamilyang Pilipino Program.

RESOLVED, FURTHER, to furnish copy of this Resolution to all concerned, for their information and guidance.


