“RESOLUTION NO. 2017-179

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER (MMM&MC) REPRESENTED BY ITS MEDICAL CENTER CHIEF II, MARIA LOUDES K. OTAYZA, MD, FPOGS, CESO V FOR THE IMPLEMENTATION OF THE POINT OF CARE PROGRAM.

WHEREAS, Article XIII, Sec. 11 of the 1987 Philippine Constitution stipulates that “The state shall adopt an integrated and comprehensive approach to health development”, which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the under-privileged, sick, elderly, disabled, women, and children. The state endeavor to provide free, medical care to paupers;

WHEREAS, corollary to this provision, the Local Government Code provides that Local Government Units shall provide health services which includes the implementation of programs and projects on primary health care, maternal and child care, and non-communicable disease control services; purchase of medicines, medical supplies and equipments needed the services herein enumerated;

WHEREAS, Section 444 of the Local Government Code of 1991 requires prior authorization from the Sangguniang Bayan before the Local Chief Executive can effectively execute or sign documents for and on behalf of the municipality, to wit:

(vi) Upon authorization by the Sangguniang Bayn, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, after thorough study and deliberation, the Sangguniang Bayan deems it necessary and proper to approve this resolution;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIAN BAYAN IN SESSION to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the Mariano Marcos Memorial Hospital and Medical Center (MMM&MC) represented by its Medical Center Chief II, Maria Loudes K. Otayza, MD, FPOGS, CESO V for the implementation of the Point of Care Program.

RESOLVED, FURTHER, to furnish copy of this Resolution to all concerned, for their information and guidance.


On motion of Member Orlando B. Badua, duly seconded, the foregoing resolution was unanimously approved.
