“RESOLUTION NO. 2017-214

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE STA. ROSA ACADEMY OF SAN NICOLAS, ILOCOS NORTE, INC. FOR THE IMPLEMENTATION OF THE SENIOR HIGH SCHOOL (SHS) PROGRAM IN PRIVATE SCHOOLS FOR THE SCHOOL YEAR (SY) 2016-2017 AND ONWARDS.

WHEREAS, the LGU shall support the Sta. Rosa Academy, the only Catholic school in town, in the implementation of the Enhanced Basic Education Act of 2013 enabling the school to acquire for a provisional license to open a senior high school, Grades 11 and 12, starting SY 2016-2017 and onwards.

WHEREAS, the Sta. Rosa Academy of San Nicolas, Ilocos Norte, Inc. will offer Technical-Vocational and Livelihood Tracks with the four strands; Cookery, Baking and Bread and Pastry Production, Food Processing and Housekeeping and Academics with its three strands; Humanities, Education and Social Science.

WHEREAS, the parties shall exert efforts in the establishment of partnership with the Parent-Teacher-Community Association, if any, the Local Government Unit, non-government organizations, and all other organizations that can help in sustaining the operations of the Senior High School, grades 11 and 12.

WHEREAS, Section 444 of the Local Government Code of 1991 requires prior authorization from the Sangguniang Bayan before the Local Chief Executive can effectively execute or sign documents for and on behalf of the municipality, to wit:

(vi) Upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the Sta. Rosa Academy of San Nicolas, Ilocos Norte, Inc. for the implementation of the Senior High School (SHS) Program in private schools for the School Year (SY) 2016-2017 and onwards.

RESOLVED, FURTHER, to furnish copy of this Resolution to all concerned, for their information and guidance.


On motion of Member Angel Miguel L. Hernando, duly seconded, the foregoing resolution was unanimously approved.


