“RESOLUTION NO. 2017-215

A RESOLUTION ADOPTING THE RDC-I RESOLUTION NO. 48, SERIES OF 2017 “ENJOINING LOCAL GOVERNMENT UNITS (LGUs) IN REGION I TO ADOPT THE COMMUNITY AND SERVICE –ORIENTED POLICING SYSTEM AS THE FRAMEWORK FOR CRIME PREVENTION IN REGION I”.

WHEREAS, Section 2 of Republic Act 6975 or the Department of the Interior and Local Government Act of 1990 provides the three policing objectives of the Philippine National Police (PNP), namely: 1) to promote peace and order; 2) to ensure public safety; and 3) to further strengthen local government capability aimed towards the effective delivery of the basic services to the citizenry and that the State shall bolster a system of coordination and cooperation among the citizenry, local executives and the integrated law enforcement and public safety agencies;

WHEREAS, Republic Act 8551 mandates the PNP to be a community and service oriented agency and responsible for the maintenance of peace and order and public safety;

WHEREAS, pursuant to the two aforementioned Republic Acts, the National Police Commission (NAPOLCOM) issued Resolution No. 2015-342 on 21 July 2015 empowering the PNP to perform its role as a community and service-oriented agency through the adoption of the CSOP System involving the Local Chief Executives (LCEs), the PNP and the community.

WHEREFORE, be it **RESOLVED** as it is hereby resolved by the Sangguniang Bayan assembled in session to adopt the RDC-I Resolution No. 48, Series of 2017 “Enjoining Local Government Units (LGUs) in Region I to Adopt the Community and Service-Oriented Policing System as the Framework for Crime Prevention in Region I.

RESOLVED FURTHER to transcribe copies of this resolution and furnish same to the all concerned for their information and considerate action.


