“RESOLUTION NO. 2017-216

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE SOCIAL SECURITY SYSTEM AND THE WORKERS AND JOB ORDER CONTRACTUALS (INFORMAL SECTOR GROUP) OF LGU SAN NICOLAS, ILOCOS NORTE FOR THE PAYMENT OF THEIR PREMIUMS AS A GROUP.

WHEREAS, the SSS is intensifying its coverage to provide social security protection for the informal sector workers nationwide through various programs including its e-AlkanSSSy Program;

WHEREAS, the ISG, a group whose membership is not covered by the Government Service Insurance System (GSIS) and with no SSS registered employer, has signified its intention to participate in the Program;

WHEREAS, the LGU on its part has signified its intention to assist the SSS in the implementation of the Program;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the Social Security System and the Workers and Job Order Contractuals (Informal Sector Group) of LGU San Nicolas, Ilocos Norte for the payment of their premiums as a group.

RESOLVED, FURTHER, to furnish copy of this Resolution to all concerned, for their information and guidance.


On motion of Member Norberto S. Dadiz, Jr., duly seconded, the foregoing resolution was unanimously approved.




