“RESOLUTION NO. 2017-219

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE FOR THE PROVISION OF P650,000.00 FOR THE SUSTAINABLE GARLIC PRODUCTION PROJECT.

WHEREAS, the DA is the principal government agency mandated to develop the country’s agriculture and fishery sector through the provision of support programs and training services to farmers/producers group to attain food self-sufficiency through efficient and competitive production costs for global competitiveness;

WHEREAS, the DA is responsible for the promotion of agricultural development by providing framework, public investments, and support services needed for domestic and export-oriented business enterprises;

WHEREAS, it shall be the primary concern of the DA to improve farm income and generate work opportunities for farmers, fishermen and other rural workers. It shall encourage people’s participation in agricultural development through sectoral representation in agricultural policy-making bodies so that the policies, plans and programs of the Department are formulated and executed to satisfy their needs;

WHEREAS, the DA, under RA 7900 otherwise known as “High Value Crops Development Act of 1995”, is further mandated to “link-up agribusiness cooperatives directly with consumer cooperatives to provide marketing outlets and assure relatively higher and stable prices”;

WHEREAS, the LGU San Nicolas is recognized by the DA as a partner in spearheading development efforts and activities of DA programs and projects;

WHEREAS, the LGU San Nicolas has projects for the welfare of the garlic farmers and foremost for the development of the garlic industry;

WHEREAS, the DA and the LGU San Nicolas have common complementary objectives, and have signified their intention, willingness and cooperation aim to develop the operational mechanism of agricultural cooperatives through collective action in meeting the food security targets of the government;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the Department of Agriculture for the provision of P650,000.00 for the Sustainable Garlic Production Project.

RESOLVED, FURTHER, to furnish copy of this Resolution to all concerned, for their information and guidance.

On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, the foregoing resolution was unanimously approved.


