“RESOLUTION NO. 2017-230

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALFREDO P. VALDEZ, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE IMPLEMENTATION OF THE PROVISION OF POTABLE WATER SUPPLY – SAGANA AT LIGTAS NA TUBIG SA LAHAT (SALINTUBIG) PROGRAM.

WHEREAS, the government continuous to implement the provision of Potable Water Supply – Sagana at Ligtas na Tubig sa Lahat (SALINTUBIG) Program to pursue its commitment to provide water particularly for the poor and waterless communities;

WHEREAS, the program aims to contribute to the attainment of the goal of providing potable water to the entire country and the targets defined in the Philippine Development Plan 2011-2016, Millennium Development Goals (MDG), and the Philippine Water Supply Sector Roadmap and the Philippine Sustainable Sanitation Roadmap;

WHEREAS, the DILG is the lead executing agency responsible for the provision of grant financing and capacity development to increase access to water and sanitation services and improve capacities of the Local Government Units (LGUs) and Water Service Providers (WSPs) in the planning, implementation and management of water supply facilities in a sustainable manner;

WHEREAS, the provision for potable water supply are allocated in the FY 2017 budget of the DILG under Republic Act 10651 (FY 2017 General Appropriation Act);

WHEREAS, the Municipality of San Nicolas, Ilocos Norte has been identified by Program as one of the priority areas and had complied with all the requirements;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, Hon. Alfredo P. Valdez, Jr. to enter into a Memorandum of Agreement (MOA) with the Department of the Interior and Local Government (DILG) for the Implementation of the Provision of Potable Water Supply – Sagana at Ligtas na Tubig sa Lahat (SALINTUBIG) Program.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, foregoing resolution was unanimously approved.


