**“RESOLUTION NO. 2017-79**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BETWEEN THE MUNICIPAL HEALTH OFFICE, OWNED, ADMINISTERED, MANAGED AND FINANCED BY THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE REPRESENTED BY THE MUNICIPAL MAYOR AND THE MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER, GERTES CLINIC AND HOSPITAL, AND THE BLACK NAZARENE HOSPITAL TO PROVIDE SERVICES ALLOWED FOR REFERRAL INITIALLY FOR CHEST X-RAY AND BIRTHING FACILITIES.**

**WHEREAS**, the Municipal Health Office (MHO) to date is still unable to deliver the required Chest X-ray service, due to the unavailability of X-ray facility, thus the patients are referred to the MMMH and MC, Gertes Clinic and Hospital, and the Black Nazarene Hospital, an accredited health care providers with X-ray and birthing facilities;

**WHEREAS**, the PCB I: Tamang Serbisyo Sa Kalusugan ng Pamilya (TSEKAP) would only cover Chest X-ray examination and other parts of the body are excluded;

**WHEREAS**, the beneficiary shall present the Updated MDR prior to consultation and Chest X-ray examination;

**WHEREAS**, the concerned municipality shall pay the hospital the amount of not less than FIVE HUNDRED PESOS (P500.00) for adult and pedia;

**WHEREAS**, the Terms of Payments shall be the following:

1. Bills will be forwarded every end of the month and payment shall be made on the 15<sup>th</sup> day of the ensuing month;
2. Credit limit of P50,000.00 will be given and a temporary suspension will be implemented on the 15<sup>th</sup> day after the account is billed if it remains unpaid.

**WHEREAS**, the Municipal Health Officer, the authorized signatory of referrals should accomplish the prescribed Phil Health Referral Form which shall be presented to his receiving health care provider. A referral slip from the MHO shall be brought to the Chief of Hospital's Office;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx xxx xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby RESOLVED by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, Hon. Alfredo P. Valdez, Jr. to enter into a Memorandum Of Agreement (MOA) for and in between the Municipal Health Office, owned, administered, managed and financed by the Municipality of San Nicolas, Ilocos Norte represented by the Municipal Mayor and the Mariano Marcos Memorial Hospital and Medical Center, Gertes Clinic and Hospital, and the Black Nazarene Hospital to provide services allowed for referral initially for Chest X-Ray and birthing facilities.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, foregoing resolution was unanimously approved.
