“RESOLUTION NO. 2016-198

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY ITS REGIONAL DIRECTOR OF FIELD 1, DIR. MARCELO NICOMEDES J. CASTILLO FOR THE IMPLEMENTATION OF THE BOTTOM-UP BUDGETING (BUB) PROGRAM OF THE MUNICIPALITY FOR THE FISCAL YEAR 2016 BUDGET RELATED TO THE EARLY CHILDHOOD CARE AND DEVELOPMENT COUNCIL (ECCDC).

WHEREAS, the Human Development and Poverty Reduction Cluster (HDPRC), the Good Governance and Anti-Corruption Cluster (GGAC) and the Economic Development Cluster (EDC) organized under Executive Order No. 43, Series of 2011, issued DBM-DILG-DSWD-NAPC Joint Memorandum Circular (JMC) No. 7, Series of 2016 on November 3, 2015 to serve as the basis for the implementation of Bottom-Up Planning and Budgeting (BUB) for the FY 2016 budget preparation;

WHEREAS, the BUB which aims to make the planning and budgeting processes of both local and national government more participatory, by involving grassroots communities in the delivery of national services to poor communities be adapted by different National Agencies and Local Government Agencies as part of their poverty reduction effort;

WHEREAS, the DSWD, through the Regional Project Management Offices shall manage the review and assessment of projects and approval and disbursement of BUB funds to the respective eligible LGUs and CSOs to implement the BUB Projects as stipulated in the DSWD Administrative Order No. AO 03, Series of 2013;

WHEREAS, the citizens and their organizations are encouraged to participate in all aspects of implementation of BUB, wherein the DSWD, through its Regional Project Management Offices will provide necessary technical assistance to the implementing partners not limited to the non-KC municipalities that will implement projects through the Community-Driven Development (CDD) approach.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Represented by its Regional Director of Field 1, Dir. Marcelo Nicomedes J. Castillo for the implementation of the Bottom-Up Budgeting (BUB) Program of the Municipality for the Fiscal Year 2016 Budget related to the Early Childhood Care and Development Council (ECCDC).

RESOLVED, FINALLY, to transmit copy of this resolution to all concerned offices for their information and appropriate action.

On motion of Member Domingo C. Ambrocio, Jr., duly seconded, foregoing resolution was unanimously approved.




