WHEREAS, the municipality is expecting the amount of Eighty Five Million Two Hundred Two Thousand One Hundred One Pesos (P85,202,101.00) as its Internal Revenue Allotment (IRA) share for the year 2017;

WHEREFORE, on motion of Member Norberto S. Dadiz, Jr., duly seconded, the foregoing resolution was unanimously approved.


