## A RESOLUTION APPROVING THE ESTABLISHMENT OF AN ECO-TOURISM PARK AND CROCODILE FARM PROJECT OF THE VENVI-AGRO INDUSTRIAL VENTURES CORPORATION AT BRGY. 21, SAN AGUSTIN, SAN NICOLAS, ILOCOS NORTE SUBJECT TO COMPLIANCE TO EXISTING NATIONAL AND LOCAL LAWS APPURTENANT THERETO.

**WHEREAS**, the Venvi-Agro Industrial Ventures Corporation has signified its intention to establish an Eco-Tourism Park and Crocodile Farm at Brgy. 21, San Agustin, San Nicolas, llocos Norte;

WHEREAS, upon endorsement to the Office of the Sangguniang Bayan, the Committee of the whole deemed it proper to invite the presence of Engr. Jeremiah Ancheta, Vice-President of the Venvi-Agro Industrial Ventures Corp. to enlighten the Body on the components of the program and concerned department heads of the Local Government Unit to look into the possibility of putting up the project in the municipality;
