**A RESOLUTION ADOPTING THE PUBLIC FINANCIAL MANAGEMENT IMPROVEMENT PLAN OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.**

**WHEREAS**, this Office is in receipt of the letter of the Local Chief Executive dated October 4, 2016 requesting the Sangguniang Bayan to adopt the Public Financial Management Improvement Plan (PFMAT) of the municipality;

**WHEREAS**, the PFMAT is an assessment mechanism in which the local government unit could now measure the present PFM system and consequently identify critical dimensions an areas that needs improvement;

**WHEREAS**, as per PFM System Assessment Result, the municipality obtained the highest score on the critical dimensions of credibility of the budget and citizen’s participation. Further, the municipality has been able to collect 90-100% of the estimated revenues for the year under review. The lowest critical dimensions score are in the area of internal and external audit and Comprehensive and Transparency;

**WHEREAS**, the adoption and implementation of the PFMAT is included in the proposed 2016-2019 Executive-Legislative Agenda and 2016 Annual Investment Program;

**NOW, THEREFORE, BE IT RESOLVED BY THE SANGGUNIANG BAYAN**, in session duly assembled, to adopt the Public Financial Management Improvement Plan of the Municipality of San Nicolas, Ilocos Norte, as hereto attached;


