**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ALFREDO P. VALDEZ, JR., M.D., REPRESENTING THE LOCAL GOVERNMENT UNIT OF SAN NICOLAS, ILOCOS NORTE TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, REPRESENTED BY THE REGIONAL DIRECTOR, JULIE J. DAQUIOAG, CESO IV FOR THE IMPLEMENTATION OF THE PERFORMANCE CHALLENGE FUND (PCF) IN THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) FOR THE CONSTRUCTION OF SLOPE PROTECTION WALL AT THE ENGINEERED SANITARY LANDFILL OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE, AND CERTIFYING THAT SAID PROJECT IS INCLUDED IN THE CY 2017 ANNUAL INVESTMENT PLAN (AIP) OR LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) OR MUNICIPAL DEVELOPMENT INVESTMENT PROGRAM OF THE MUNICIPALITY.**

**WHEREAS**, the Performance Challenge Fund (PCF) is being administered by the Department of the Interior and Local Government (DILG) in collaboration with the Department of Budget and Management (DBM) to recognize good governance performance particularly in the adoption of good local governance;

**WHEREAS**, the Municipality of San Nicolas, Ilocos Norte is one of the recipients of the Performance Challenge Fund (PCF) in the amount of Three Million Pesos for the construction of a Slope Protection Wall at the Engineered Sanitary Landfill;

**WHEREAS**, the construction of a slope protection wall at the Engineered Sanitary Landfill is included in the 2017 Annual Investment Program of the Municipality of San Nicolas, Province of Ilocos Norte;

**WHEREAS**, upon thorough review of the terms and conditions of the Memorandum of Agreement (MOA), the same are found to be in order;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Bayan assembled in session to authorize as it hereby authorizes the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the DILG-RO for the implementation of the PCF funded project in the amount of P 3,000,000.00 for the construction of a Slope Protection Wall at the Engineered Sanitary Landfill.




