A RESOLUTION REQUESTING THE HONORABLE IMEE R. MARCOS, GOVERNOR OF THE PROVINCE OF ILOCOS NORTE, THROUGH THE SANGGUNIANG PANLALAWIGAN TO TAKE APPROPRIATE ACTION IN THE UNABATED BURNING OF COGON GRASS AT THE PADSAN RIVER IN LAOAG CITY.

WHEREAS, the burning of cogon grass at the bed of the Padsan River is becoming a perennial problem of the people of San Nicolas;

WHEREAS, the massive burning is apparently intentional, which is a clear violation of environmental laws and other pertinent local ordinances of the province as well as the City of Laoag including the Municipality of San Nicolas prohibiting such act;

WHEREAS, the ashes severely affect the residential areas in the poblacion of the municipality bringing discomfort and health woes of the residents including those visitors and tourists frequenting the Valdez Center;

WHEREAS, it is imperative that concerned agencies with competent jurisdiction should take firm action to stop this wrongdoing in accordance with existing national and related local laws;

WHEREFORE, be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session earnestly request the Honorable Imee R. Marcos, Governor of the Province of Ilocos Norte thru the Sangguniang Panlalawigan to take appropriate action in the unabated burning of cogon grass at the Padsan River in Laoag City.




