**RESOLVED FURTHER**, to furnish copy of this resolution to Land Bank of the Philippines, and all concerned, for their information and guidance.


On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, the foregoing resolution was unanimously approved.


