**“RESOLUTION NO. 2018-346**

**A RESOLUTION CONCURRING THE TEMPORARY APPOINTMENT OF MRS. FELY M. BARAYUGA AS MUNICIPAL CIVIL REGISTRAR (MCR) OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.**

**WHEREAS**, the provisions of Rule XVIII, Art. 119 of the Rules Implementing the Local Government Code of 1991, requires that the appointment of heads of departments by the Mayor including the position of Municipal Civil Registrar (MCR) must be concurred by the majority of all the Sangguniang Bayan Members, subject to the Civil Service Laws, Rules and Regulations;

**WHEREAS**, the position of MCR has been vacated due to the retirement of the Mr. Rodrigo T. Tumamao, the former Municipal Civil Registrar and to date said position has not yet been filled up;

**WHEREAS**, pursuant to RA 9048 the MCR is vested with authority to cause the correction of clerical or typographical errors in an entry or change of first name or nickname in the Civil register without need of a judicial order;

**WHEREAS**, RA 10172 further authorizes the City or Municipal Civil Registrar or the Consul General to correct clerical or typographical errors in the day and month in the date of birth or sex of a person appearing in the Civil Register without need of a judicial order, amending for this purpose Republic Act numbered Ninety Forty-Eight;

**WHEREAS**, there have been petitions in the office of the MCR on matters relative to the above foregoing but due to the absence of an officer, these have not been acted upon, to the detriment of public service, hence the need for an appointment of a Temporary MCR;

**WHEREAS**, the Local Chief Executive thru the Human Resource and Management Officer III has inquired in the Civil Service Commission as to the possibility of appointing of a Temporary Civil Registrar, which the Commission answered in the affirmative paving the way for the appointment of Ms. Fely M. Barayuga as Temporary Municipal Civil Registrar;

**WHEREAS, MRS. FELY M. BARAYUGA** having found to posses the minimum qualifications required for a Temporary Municipal Civil Registrar (MCR), the Sangguniang Bayan hereby concurs with her appointment made by the Local Chief Executive;

**NOW, THEREFORE**, be it **RESOLVED** as it hereby **RESOLVED**, to concur as the Sangguniang Bayan hereby concurs the temporary appointment of Mrs. Fely M. Barayuga, as the Municipal Civil Registrar of San Nicolas, Province of Ilocos Norte.

**RESOLVED FURTHER**, to direct the Sanggunian Secretary to transcribe copies of this resolution and thereof be furnished to the Honorable Mayor, Alfredo P. Valdez, Jr., the Human Resource and Management Officer, the Civil Service Commission and Mrs. Fely M. Barayuga for their information.


On motion of Member Manuel D. Coloma, Sr., and unanimously seconded by all the members present, the foregoing resolution was unanimously approved.
