**“RESOLUTION NO. 2018-347**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A CONTRACT OF PROFESSIONAL SERVICES WITH DR. LOUIE A. GUERRERO, MD., FPCR, A DULY LICENSED PHYSICIAN AND A FELLOW OF THE PHILIPPINE COLLEGE OF RADIOLOGISTS TO RENDER SERVICE FOR THE MUNICIPAL HEALTH OFFICE OF THE MUNICIPALITY.**

**WHEREAS**, the municipality is desirous of engaging the service of a radiologist who is duly certified by the Philippine College of Radiologists;

**WHEREAS**, the Radiologist is willing to render service for the Municipal Health Office under such terms and conditions stated in the Contract of Professional Services;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

xxx

xxx

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx*

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

*(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”*

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to authorize the Local Chief Executive to enter into a Contract of Professional Services with Dr. Louie A. Guerrero, MD., FPCR, a Duly Licensed Physician and a fellow of the Philippine College of Radiologists to render service for the Municipal Health Office of the municipality.

**RESOLVED, FURTHER,** to furnish copy of this Resolution to all concerned, for their information and guidance.


On motion of Member Orlando B. Badua, duly seconded, the foregoing resolution was unanimously approved.
