“RESOLUTION NO. 2018-370

A RESOLUTION CONCURING THE APPOINTMENT OF DR. SINAMAR ANN DE LA CRUZ-ABANDO AS MUNICIPAL HEALTH OFFICER (MHO) OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the provisions of Rule XVIII, Art. 119 of the Rules Implementing the Local Government Code of 1991, requires that the appointment of heads of departments by the Mayor including the position of Municipal Health Officer (MHO) must be concurred by the majority of all the Sangguniang Bayan Members, subject to the Civil Service Laws, Rules and Regulations;

WHEREAS, the position of MHO has been vacated due to the retirement of Dr. Leoneil Obien, the former Municipal Health Officer;

WHEREAS, consistent with the national policy to afford every citizen health care and support, it is imperative for the Local Government Unit (LGU) to fill up the vacancy so as not to hamper the delivery of health and medical services to the people of San Nicolas

WHEREAS, on March 21, 2018, DR. SINAMAR ANN DE LA CRUZ-ABANDO was appointed by the Municipal Mayor as the new MHO after consideration of her qualifications as prescribed by existing laws and the Civil Service Commission’s rules and regulations;

WHEREAS, DR. SINAMAR ANN DE LA CRUZ-ABANDO having found to have met the minimum qualifications of a Municipal Health Officer, the Sangguniang Bayan hereby concurs her appointment made by the Local Chief Executive;

NOW, THEREFORE, be it **RESOLVED** as it hereby **RESOLVED**, to concur as the Sangguniang Bayan hereby concurs the appointment of Dr. Sinamar Ann De La Cruz-Abando, as the Municipal Health Officer of San Nicolas, Province of Ilocos Norte.

RESOLVED FURTHER, to direct the Sanggunian Secretary to transcribe copies of this resolution and thereof be furnished to the Honorable Mayor, Alfredo P. Valdez, Jr., the Human Resource and Management Officer, the Civil Service Commission and Dr. Sinamar Ann De La Cruz-Abando for their information.
