WHEREAS, due to the mandatory retirement of Dr. Leoneil C. Obien, the position Municipal Health Officer (MHO) of the municipality was vacated on January 31, 2018;

Baguio of Brgy. 12, San Nicolas, Ilocos Norte in assuming the position of an OIC-MHO from February 5, 2018 to March 20, 2018;
