“RESOLUTION NO. 2018-376

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGIONAL OFFICE I FOR THE IMPLEMENTATION OF THE GOVERNMENT INTERNSHIP PROGRAM (GIP).

WHEREAS, the DOLE through Regional Office I and the Municipality of San Nicolas have agreed to enter into an understanding for the purpose of achieving the goals of the Government Internship Program of the DOLE, that is, to provide opportunities and engage young workers to serve the general public in government agencies/entities’ at the national and local level;

WHEREAS, the DOLE through Regional Office I, as the implementor of the GIP undertakes to provide and assign the interns-beneficiaries to the municipality to perform tasks and duties;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Memorandum of Understanding with the Department of Labor and Employment (DOLE) Regional Office I for the Implementation of the Government Internship Program (GIP).

RESOLVED, FURTHER, to transmit copy of this resolution to all concerned offices for their information and appropriate action.


On motion of Member Manuel D. Coloma, Sr., duly seconded, the foregoing resolution was unanimously approved.


