“MUNICIPAL ORDINANCE NO. 2018-11

AN ORDINANCE PRESCRIBING THE FEES AND GUIDELINES FOR THE USE AND OPERATION OF THE MUSEO SAN NICOLEÑO (BUABOBUABO) AND FOR OTHER PURPOSES.

WHEREAS, the Museo San Nicoleno (*Buabobuabo*) was inaugurated on December 27, 2017 as part of the Quadricentennial celebration of the municipality as an independent pueblo or town;

WHEREAS, the museum serves as the repository of the rich cultural heritage of San Nicolas which can be showcased as learning center and new tourist attraction to further enhance the heritage conservation and tourism program of the local government unit;

WHEREAS, on the literacy and continuing education and culture-based governance programs, the Local School Board, San Nicolas Literacy Coordinating Council, San Nicolas Council for the Arts and Culture, and San Nicolas Tourism Council fully support the initiative to utilize the museum as a learning and recreational hub for students, learners, and visitors;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of San Nicolas, Ilocos Norte in session duly assembled, that:

SECTION 1. Title. This Ordinance shall be known as **“AN ORDINANCE PRESCRIBING THE FEES AND GUIDELINES FOR THE USE AND OPERATION OF THE MUSEO SAN NICOLEÑO (BUABOBUABO) AND FOR OTHER PURPOSES”**.

SECTION 2. Declaration of Principle. – The municipality hereby declares that, through the establishment of the Museo San Nicoleño (Buabobuabo) where significant historical timeline on San Nicolas and a collection of valuable objects, artifacts on history, culture, arts, and sciences are put on exhibition for the general public, a balanced atmosphere where the historic past coexists in harmony with modern society is created.

SECTION 3. Imposition of Fees. - There is hereby imposed an entrance fee to every visitor of the museum as follows:

- a. Regular Fee
 1. Tourists and Guests – P20.00/Head
- b. Special/Discounted Fees
 1. Students – P10.00
 2. Persons with Disability and Senior Citizens – P10.00
 3. Tourists – P20.00

Subject to the sound discretion of the Local Chief Executive, the museum fees may not be imposed on the following:

- 1. Official visitors of the municipality
- 2. Special or cultural program initiated by the municipality

The fee collected, which is in the nature of trust fund, shall be used for the maintenance and operational expenses of the museum and for the cultural heritage conservation program of the municipality.

SECTION 4. Museum Management. – The Municipal Tourism Officer shall be in-charge for the operation and management of the museum.

The local government unit shall train museum guides for the purpose.

SECTION 5. Operation of the Museum. – The Museum shall be open from 9:00 AM to 4:00 PM from Mondays to Friday. It may also open on weekends and holidays upon prior appointment.

SECTION 6. Research and Outreach Educational Program. – The municipal government in coordination with the Department of Education shall come up with Research and Outreach Educational Program where the significance and contents of the museum will cascade to the, schools, barangays, and community.

SECTION 7. Separability Clause. - If for any reason, any section of this Ordinance is declared illegal or unconstitutional, other sections hereof which are not affected shall continue to be in full force and effect.

SECTION 8. Repealing Clause. - All previous issuances, ordinance, rules and regulations, provisions or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance, are hereby repealed or modified accordingly.


SECTION 9. Effectivity. - This ordinance shall take effect ten (10) days after posting the same in the Bulletin Board at the entrance of the Municipal Hall and two (2) other conspicuous places in the municipality.
