**“MUNICIPAL ORDINANCE NO. 2018-14**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED FORTY NINE THOUSAND EIGHT HUNDRED SEVENTY ONE PESOS (P149,871.00) FOR THE PROCUREMENT OF FERTILIZER WHICH WILL BE CHARGEABLE UNDER THE SHARE OF THE MUNICIPALITY FROM THE BURLEY AND NATIVE TOBACCO EXCISE TAX (RA 8240).**

**WHEREAS**, pursuant to RA 8240, the Municipality of San Nicolas, Ilocos Norte has a share in the excise tax collected with a total amount of P149,871;

**WHEREAS**, Local Budget Memorandum and Issuances and recent jurisprudence provide guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the Collections of Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to LGUs;

**WHEREAS**, the procurement of fertilizer for farmers are developmental and will benefit the farmers in the municipality;

**WHEREAS**, to fully implement the same and to substantially comply with the rules and regulations on accounting and auditing of government projects using public funds, a list of identified programs are prepared for consideration;

**NOW, THEREFORE, BE IT ORDAINED THAT:**

**SECTION 1.** There is an available fund amounting to P70,128.00, P27,038.00 and P52,705.00 from the proceeds of RA 8240 for Calendar Years 2015, 2016 & 2017;

**SECTION 2.** *The above mentioned fund will be utilized for the procurement of fertilizers as follows:*


**SECTION 4. EFFECTIVITY.** This ordinance shall take effect after complying with its posting and publication requirements as provided by the Local Government Code of 1991.
