“MUNICIPAL ORDINANCE NO. 2018-16

AN ORDINANCE REVERTING THE AMOUNT OF ONE MILLION SIX HUNDRED EIGHTY FOUR THOUSAND TWO HUNDRED FORTY EIGHT PESOS AND FIFTY NINE CENTAVOS (P1,684,248.59) FROM THE PERSONAL SERVICES SAVINGS OF VACANT POSITIONS FROM JANUARY TO MAY 2018 AND APPROPRIATING THE SAME FOR THE IMPLEMENTATION OF VARIOUS PROGRAMS, PROJECTS, AND ACTIVITIES OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, pursuant to Supplemental Budget No. 2 for Fiscal Year 2018, there exists an available fund in the amount of One Million Six Hundred Eighty Four Thousand Two Hundred Forty Eight Pesos And Fifty Nine Centavos (P1,684,248.59) representing Personal Services Savings (Vacant Positions) from January to May 2018;

WHEREAS, the available funds are hereunder appropriated for the grant of loyalty pay to qualified municipal employee and for the implementation of various programs, projects and activities of the Municipality of San Nicolas, Ilocos Norte;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of One Million Six Hundred Eighty Four Thousand Two Hundred Forty Eight Pesos And Fifty Nine Centavos (P1,684,248.59) representing Personal Services Savings (Vacant Positions) from January to May 2018;

SECTION 2. Appropriation. The amount of One Million Six Hundred Eighty Four Thousand Two Hundred Forty Eight Pesos And Fifty Nine Centavos (P1,684,248.59) is hereby reverted and shall be appropriated for the following, as follows:


