"MUNICIPAL ORDINANCE NO. 2018-22

AN ORDINANCE PRESCRIBING FEES FOR THE NEW LABORATORY AND HEALTH EXAMINATION SERVICES AVAILABLE AND CONDUCTED IN THE MUNICIPAL HEALTH CENTER, SUPPLEMENTING FOR THE PURPOSE SECTION ONE (1) OF MUNICIPAL ORDINANCE NO. 2013-14.

WHEREAS, Sections 16 and 17 of Republic Act 7160 otherwise known as the Local Government Code of 1991 vest the Municipality of the power to promote the general welfare specifically "health and safety" of its constituents;

WHEREAS, in the exercise of its general welfare power, the Municipality is expressly authorized to prescribe, impose and levy reasonable fees and charges for the generation of funds to maximize the implementation of its programs to the community with the end in view of fully uplifting the scope of its social services;

WHEREAS, in line with the continuing health program of the Municipality, there are new equipments acquired resulting to an expanded laboratory services that are readily available to be offered and provided to the constituents at the most minimal cost;

WHEREAS, considering the availability of additional services, it likewise entails the need to source out funds for its continuous operation and maintenance, coupled with the required payment of honorarium and/or incentives of medical or laboratory personnel; hence, the necessity of imposing and prescribing fees, at the most reasonable and minimal cost, for said purpose;

WHEREFORE, be it enacted by the Sangguniang Bayan in session duly assembled the following:

SECTION 1. Section One (1) of Municipal Ordinance No. 2013-14 referred to as "An Ordinance Imposing Fees for Laboratory and Health Related Examinations Conducted in the Municipal Health Center and Providing Exemptions Thereto" is hereby supplemented to be referred to and read as follows:



Page 2, Municipal Ordinance No. 2018-22;

SECTION 1-B. Prescribed Fees for Other Laboratory and Health Related Services Conducted at the Municipal Health Center. There shall be imposed fees on the following laboratory test and services:

The aforesaid respective fee/s shall be paid to the Municipal Treasurer's Office before the health, laboratory or related service is made and result of examination thereof is issued.

SECTION 2. *Effectivity*. This Ordinance shall take effect fifteen (15) days from the completion of its publication as required under Section 188 of Republic Act 7160 otherwise known as the Local Government Code of 1991.
