**“RESOLUTION NO. 2018-422**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE ALFREDO P. VALDEZ, JR. M.D., TO INITIATE THE EXPRORIATION PROCEEDINGS OF LOT NOS. 21252, 21254, 21246 AND 21247 LOCATED AT BRGY. 20, SAN PABLO, SAN NICOLAS, ILOCOS NORTE WHICH WILL BE USED AS THE SITE OF THE SMALL WATER IMPOUNDING PROJECT TO BE CONSTRUCTED IN THE SAID BARANGAY.**

**WHEREAS**, the Sangguniang Bayan has enacted Municipal Ordinance No. 2018-07, to expropriate Lot No. 21252 with a total area of 4,691 and Lot No. 21254 with a total area of 4,852 owned by Mr. Alfredo Agustin; Lot No. 21246 with a total area of 11,973 owned by Ms. Victoria Cristobal; and Lot No. 21247 with a total area of 5,276 owned by the Heirs of Mr. Mateo Salvador to be affected by the proposed construction of a Small Water Impounding Project (SWIP) at Brgy. 20, San Pablo, San Nicolas, Ilocos Norte.

**WHEREAS**, the Local Chief Executive is empowered to represent the municipality in pursuit of his mandate provided under Section 16 of the Local Government Code of 1991 and other related and existing laws, including the power to represent the LGU in any judicial or quasi-judicial proceedings upon authorization of the Sangguniang Bayan;

**WHEREAS**, the Sangguniang Bayan whom it is lodged the power of expropriation or the power of eminent domain, hereby grants the authority to the Mayor to initiate filing of the appropriate petition in the court of competent jurisdiction for the expropriation of Lot Nos. as the specifically described in Municipal Ordinance No. 2018-07;

**WHEREFORE**, be it RESOLVED as it is hereby RESOLVED by te Sangguniang Bayan in session, to grant authority to the Local Chief Executive, Honorable Alfredo P. Valdez, Jr. to initiate the expropriation proceedings of Lot Nos. 21252, 21254, 21246 and 21247 located at Brgy. 20, San Pablo, San Nicolas, Ilocos Norte which will be used as the site of the SWIP to be constructed in the said barangay;

Resolved further to transcribe a copy of this resolution and furnish same to Honorable Mayor Alfredo P. Valdez, Jr., M.D. for his information and appropriate action.

Unanimously moved and seconded, the foregoing resolution was approved.


