RESOLUTION NO. 2018-423

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HUMAN RESOURCE MANAGEMENT OFFICER (HRMO) III, MUNICIPAL ACCOUNTANT AND MUNICIPAL TREASURER TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE UCPB SAVINGS BANK – BATAK BRANCH FOR SALARY LOAN PROGRAM TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the UCPB Savings Bank is offering to extend a salary loan program to all city/municipal employees, officers and non-officers, including elected officials;

WHEREAS, the loan program is dubbed as Payroll Service Non-DepEd (PSND). Loanable amount is based on the latest net take home pay. The tenor of the loan is pinned from 12, 24 and 36 months at a competitive interest rate;

WHEREAS, individual employees with a net take home pay of P5,000.00 after all USB deduction, thereof, are qualified to avail of the loan program.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx xxx xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

Handwritten signatures and marks at the bottom of the page.

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to authorize the Local Chief Executive, Human Resource Management Officer (HRMO) III, Municipal Accountant and Municipal Treasurer to enter into A Memorandum of Agreement (MOA) with the UCPB Savings Bank – Batac Branch for Salary Loan Program to Qualified Municipal Officials and Employees of the Municipality of San Nicolas, Ilocos Norte.

**RESOLVED, FURTHER,** to furnish copy of this Resolution to all concerned, for their information and guidance.


On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, the foregoing resolution was unanimously approved.
