“RESOLUTION NO. 2018-430

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A CONTRACT OF SALE WITH THE REGISTERED OWNERS OR HIS AUTHORIZED REPRESENTATIVE OF LOT NO. 36362-C WITH AN AREA OF 10,000 SQUARE METERS, LOT NO. 36365 WITH AN AREA OF 6,790 SQUARE METERS, LOT NO. 36367 WITH AN AREA OF 4,582 SQUARE METERS AND LOT NO. 36364 WITH AN AREA OF 10,394 SQUARE METERS LOCATED AT BARANGAY 16, SAN MARCOS, SAN NICOLAS, ILOCOS NORTE TO BE USED AS EXPANSION SITE OF THE SANITARY LANDFILL OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, pursuant to the Action Plan of the Municipal Solid Waste Management Board, the municipality had already conducted Waste Analysis Characterization Survey (WACS) where a great volume of waste come from industrial and business establishments;

WHEREAS, the DENR recommended that the municipality shall have an about seven (7) hectares of Sanitary Landfill, pursuant to the intent of Republic Act No. 9003, in order to accommodate the wastes;

WHEREAS, there is an available lot as stated above which the owner offers to sell to the municipality and that the municipality is willing to purchase said lot in order to implement the expansion for the establishment of a Sanitary Landfill;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

Page 2, Resolution No. 2018-430;

WHEREAS, this authority shall be subject to existing laws on the auditing and accounting rules and regulations on the purchase of real properties;

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Contract of Sale with the registered owners or his authorized representative of Lot No. 36362-C with an area of 10,000 square meters, Lot No. 36365 with an area of 6,790 Square Meters, Lot No. 36367 with an area of 4,582 square meters and Lot No. 36364 with an area of 10,394 square meters located at Barangay 16, San Marcos, San Nicolas, Ilocos Norte to be used as expansion site of the Sanitary Landfill of San Nicolas, Ilocos Norte.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned persons, for their information and guidance;
