### “RESOLUTION NO. 2018-445

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO SIGN ALL DOCUMENTS FOR AND IN BEHALF OF THE MUNICIPALITY FOR THE REGISTRATION OF THE NEWLY PURCHASED 6-WHEELER DUMP TRUCK WITH ENGINE NO. 6JJ1-250608, CHASSIS NO. FRR33G4-3000478, MAKE ISUZU FORWARD DUMP TRUCK AT THE LAND TRANSPORTATION OFFICE (LTO).**

**WHEREAS**, the LGU, pursuant to the Annual Investment Program (AIP) of Calendar Year 2018, purchased a dump truck for its various projects, programs and activities;

**WHEREAS**, there is a new guideline issued by the Land Transportation Office (LTO) in which the authorization of the Sangguniang Bayan to the Local Chief Executive to sign all documents for and in behalf of the municipality is needed;

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.*  
– xxx

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

*(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”*

**WHEREAS**, this authority shall be subject to existing laws on the auditing and accounting rules and regulations on the purchase of government properties;

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED, AS IT IS HEREBY RESOLVED** to authorize the Local Chief Executive to sign all documents for and in behalf of the municipality for the registration of the newly purchased 6-Wheeler Dump Truck with Engine No. 6JJ1-250608, Chassis No. FRR33G4-3000478, Make ISUZU Forward Dump Truck at the Land Transportation Office (LTO).

**RESOLVED, FURTHER,** to transcribe copies of this resolution to the Local Chief Executive and all concerned persons, for their information and guidance;

On motion of Member Efren C. Butay, duly seconded, foregoing resolution was unanimously approved.


