A RESOLUTION EARNESTLY REQUESTING THE HON. ANGEL C. ENRIQUEZ, CESO II, OFFICER-IN-CHARGE – DIRECTOR IV OF THE BUREAU OF SOILS AND WATER MANAGEMENT, FOR THE PROVISION OF ONE (1) UNIT BIO DIGESTER TO BE USED AT THE ENGINEERED SANITARY LANDFILL, THIS MUNICIPALITY.

WHEREAS, it is imperative for the Local Government Unit to draw the road map aimed to improve the quality of life of its inhabitants, pursuant to Section 16 of the Local Government Code of 1991;

WHEREAS, consistent with the National Government's program of environmental preservation and protection, the municipality has adopted plans and programs to construct and establish an Engineered Sanitary Landfill which to date is nearing its completion;

WHEREAS, component of this program is the construction of the Material Recovery Facility and the acquisition of environmental equipment including Bio-digesters;

WHEREAS, this program is initiated by the Local Government Unit and has been depending on local funds since the very start of construction without the benefit of loans;

WHEREAS, due to the inadequate resources of the Municipal Government, the acquisition and purchase of bio-digesters has been delayed, hence the town is constrained to seek the assistance of National Government agencies tasked for the implementation of the program;

WHEREFORE, be it RESOLVED as it is hereby resolved by the Sangguniang Bayan assembled in session to earnestly request the Hon. Angel C. Enriquez, CESO II, Officer-In-Charge – Director IV of the Bureau of Soils and Water Management, for the provision of One (1) Unit Bio Digester to be used at the Engineered Sanitary Landfill, this municipality.

RESOLVED FURTHER to transcribe copies of this resolution and furnish same to the Department of Agriculture and other concerned offices for their information and considerate action.
