A RESOLUTION EARNESTLY REQUESTING DIR. LUCRECIO R. ALVIAR, JR., CESO III, REGIONAL EXECUTIVE DIRECTOR, DEPARTMENT OF AGRICULTURE – REGIONAL FIELD OFFICE I FOR THE PROVISION OF ONE (1) UNIT SHREDDING MACHINE TO THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, it is imperative for the Local Government Unit to draw the road map aimed to improve the quality of life of its inhabitants, pursuant to Section 16 of the Local Government Code of 1991;

WHEREAS, consistent with the National Government’s program of poverty alleviation, the municipality has adopted plans and programs to address the needs of the farmers to enhance their earning capacity;

WHEREAS, component of this program is the provision of farm machineries which if implemented will necessary facilitate the transport of Farm produce directly to the market, thus resulting increase of income of these farm cultivators;

WHEREAS, most of these plans remain unimplemented due to the inadequate resources of the Municipal Government, hence the town is constrained to seek the assistance of National Government agencies tasked for the implementation of the agricultural program;

WHEREFORE, be it **RESOLVED** as it is hereby resolved by the Sangguniang Bayan assembled in session to earnestly request Dir. Lucrecio R. Alviar, Jr., Ceso III, Regional Executive Director, Department of Agriculture – Regional Field Office I for the provision of one (1) unit shredding machine to the Municipality of San Nicolas, Ilocos Norte.
