A RESOLUTION ADOPTING/APPROVING THE PROPOSED PROGRAMS/PROJECTS/ACTIVITIES TO BE FUNDED OUT OF THE 20% DEVELOPMENT FUND OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE FOR CALENDAR YEAR 2019 AS EMBODIED IN THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2018-03

WHEREAS, the municipality is expecting the amount of One Hundred Million Five Hundred Thirty-Three Thousand Three Hundred Sixty-Seven Pesos (P100,533,367.00) as its Internal Revenue Allotment (IRA) share for the year 2019;

WHEREAS, 20% of the total IRA amounting to Twenty Million One Hundred Six Thousand Six Hundred Seventy-Three & 40/100 Pesos (P20,106,673.00) is set aside as the Development Fund of the Municipality;

WHEREAS, the Municipal Development Council has prioritized the programs, projects, and activities to be funded out of the 20% Development Fund of the municipality to include the following:

WHEREFORE, on motion of Member Norberto S. Dadiz, Jr., duly seconded, the foregoing resolution was unanimously approved.


