WHEREAS, RA 9003, otherwise known as the Ecological and Solid Waste Management Code mandates all Local Government Units to establish their respective Sanitary Landfills within their territorial jurisdiction to stem the tide of the growing menace of climate change;

WHEREAS, the Solid Waste Management Board has conceptualized the establishment of the Engineered Sanitary Landfill located at Brgy. 16, San Marcos and has since started its construction, in compliance to the mandate of RA 9003;

WHEREAS, the closure of the open dumpsite which is bringing harmful effects to the environment as well as the hazards to the health and well-being of the people is an integral part of the Safe Closure and Rehabilitation Program (SCRP) of the Municipal Government;

WHEREFORE, the it RESOLVED as it is hereby RESOLVED by the Sangguniang Bayan in session assembled to adopt the SCRП of the municipality.
