“RESOLUTION NO. 2016-291

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE AQUINO “KOKO” PIMENTEL III, SENATE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES TO FINANCIALLY ASSIST THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FOR THE PROVISION OF INSTRUCTIONAL AND TRAINING MATERIALS TO BE USED BY THE PRE-SCHOOLERS, KINDERGARTEN AND GRADES I-III PUPILS OF THE PUBLIC SCHOOLS IN THE MUNICIPALITY.

WHEREAS, the Local Government Unit (LGU) of San Nicolas has consistently given prime attention to education and has always been included in its goals and objectives as well as its nine (9) point agenda;

WHEREAS, to effectively pursue this goal, the LGU has endeavored into various programs such as the educational assistance to poor but deserving students and the provision of other school needs and supplies to these pupils;

WHEREAS, the introduction of the K-12 program of the DepEd met apprehensions mostly from the parents complaining the additional costs they will spend for this program;

WHEREAS, it is imperative for the LGUs to provide assistance to students so as to ease the burden of the parents caused by increasing school expenses and other contingencies;

WHEREAS, the municipality has also other programs to address as mandated by law, regulations and issuances thus the fund for education is oftentimes depleted;

WHEREAS, the Honorable Mayor has been an advocate of quality education and the Sangguniang Bayan deems it appropriate to endorse to him a program that would benefit the students in the municipality specifically the pre-schoolers, kindergarten and those who are in Grades I-III;

On motion of Member Norberto S. Dadiz, Jr., duly seconded, the foregoing resolution was unanimously approved.


