“RESOLUTION NO. 2017-212

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF TOURISM REGION I REPRESENTED BY ITS REGIONAL DIRECTOR, MARTIN S. VALERA FOR FINANCIAL ASSISTANCE IN RELATION TO THE CELEBRATION OF THE QUADRICENTENNIAL ANNIVERSARY OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.

WHEREAS, DOT is the primary government agency charged with the responsibility to encourage, promote and develop tourism as a major socio-economic activity to generate foreign currency and employment and spread the benefits of tourism to a wider segment of the population with the support, assistance and cooperation of both the LGU and public sector and to assure the safe, enjoyable stay and travel of foreign and local tourists in the country;

WHEREAS, DOT in line with its mandate and subject to availability of funds, is authorized to provide assistance to LGUs in the country in support of destination development and tourism promotion;

WHEREAS, the LGU in its desire to augment its financial resources to be able to conduct the Commemoration and celebration of its 2017 quadricentennial anniversary per municipal ordinance no. 2017-11 had requested the DOT for financial support as the sponsor for this event.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, to enter into a Memorandum of Agreement (MOA) with the Department of Tourism Region I Represented by its Regional Director, Martin S. Valera for Financial Assistance in relation to the celebration of the Quadricentennial Anniversary of the Municipality of San Nicolas, Province of Ilocos Norte.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
