“MUNICIPAL ORDINANCE NO. 2018-26

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2011-21, SECTION 3, RULE ON THE ISSUANCE OF BUSINESS PERMITS AND/OR LICENSES”

BE IT ENACTED by the Sangguniang Bayan of San Nicolas, Ilocos Norte in session duly assembled, that:

SECTION 1., Section 3 of Municipal Ordinance No. 2011-21 provides that:

“SECTION 3. Rule on the Issuance of Business Permits and/or Licenses. – The president, manager, proprietor, owner, or person responsible for the management of the business establishments or entities or any business doing or operating business in the municipality must undergo orientation seminar on solid waste management. Attendance to orientation seminar scheduled by the Solid Waste Management Board shall be a prerequisite for the releasing or issuance of business permit and/or licenses.”

SECTION 2. Section 3 of Municipal Ordinance No. 2011-21 is hereby amended, to wit:

“SECTION 3. Rule on the Issuance of Business Permits and/or Licenses. The president, manager, proprietor, owner, or person responsible for the management of the new business establishments or new entities or any new business doing or operating business in the municipality must undergo orientation seminar on solid waste management. Attendance to orientation seminar scheduled by the Solid Waste Management Board shall be a prerequisite for the releasing or issuance of business permit and/or licenses.” .

SECTION 3. Repealing Clause. - All previous issuances, ordinance, rules and regulations, provisions or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance, are hereby repealed or modified accordingly.

SECTION 4. Separability Clause. - If for any reason, any section of this Ordinance is declared illegal or unconstitutional, other sections hereof which are not affected shall continue to be in full force and effect.


SECTION 5. Effectivity Clause. This ordinance shall take effect upon approval.
