“MUNICIPAL ORDINANCE NO. 2018-28

AN ORDINANCE REVERTING THE AMOUNT OF ONE MILLION SIX HUNDRED THIRTY SEVEN THOUSAND SEVEN HUNDRED SIXTY SIX PESOS AND EIGHTY TWO CENTAVOS (P1,637,766.82) FROM THE PERSONAL SERVICES SAVINGS OF VACANT POSITIONS FROM JUNE TO DECEMBER 2018 AND APPROPRIATING THE SAME FOR THE GRANT OF MONETIZATION OF LEAVE CREDITS AND TERMINAL LEAVE BENEFIT TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES, AND OTHER PROGRAMS, ACTIVITIES AND PROJECTS OF THE MUNICIPALITY.

WHEREAS, pursuant to Supplemental Budget No. 3 for Fiscal Year 2018, there exists an available fund in the amount of One Million Six Hundred Thirty Seven Thousand Seven Hundred Sixty Six Pesos and Eighty Two Centavos (P1,637,766.82) representing Personal Services Savings (Vacant Positions) from June to December 2018;

WHEREAS, the available funds are hereunder appropriated for the grant of Monetization of Leave Credits and Terminal Leave Benefit to Qualified Municipal Officials and Employees, and other programs, activities and projects of the Municipality of San Nicolas, Ilocos Norte;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of One Million Six Hundred Thirty Seven Thousand Seven Hundred Sixty Six Pesos and Eighty Two Centavos (P1,637,766.82) representing Personal Services Savings (Vacant Positions) from June to December 2018;

SECTION 2. Appropriation. The amount of One Million Six Hundred Thirty Seven Thousand Seven Hundred Sixty Six Pesos and Eighty Two Centavos (P1,637,766.82) is hereby reverted and shall be appropriated for the following, as follows:
