“RESOLUTION NO. 2018-766

A RESOLUTION AUTHORIZING THE TRANSFER OF THE FRANCHISE TO OPERATE COCKPIT IN THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE, FROM MR. CONSTANTE DANCEL, SR. TO MR. CONSTANTE DANCEL, JR., SUBJECT TO THE PROVISIONS OF MUNICIPAL ORDINANCE NO. 2018-04, AND OTHER PERTINENT LAWS RELATIVE TO THE OPERATION OF COCKFIGHTING.

WHEREAS, on November 13, 2018, the Sangguniang Bayan received a letter from Mr. Constante M. Dancel Sr. requesting the transfer of the franchise to operate cockpit in the municipality to Mr. Constante Dancel Jr., due to various reasons as stated in the letter;

WHEREAS, the matter was endorsed to the concerned committee and was favorably granted subject to ordinances relative to the matter specifically Section 4 of Municipal Ordinance No. 2018-04 to wit;

Section 4. Prohibition on Sale, Lease, Usufruct and Transfer of Franchise.

This franchise is non-transferable in character. As such, the Grantee shall not sell, assign, lease, grant the usufruct of, or transfer this franchise including any rights and privileges acquired thereunder to any person, natural or juridical, fir, or other entities, not merge with any corporation or individual without the **prior notice and approval of the Sangguniang Bayan.**

WHEREAS, it was further RESOLVED that the transferee should possess the qualifications of an individual to operate cockpit consistent with Provincial Resolution No. 2014-031 prescribing guidelines on the operation of cockpit and other pertinent laws appurtenant thereto;

WHEREFORE, in consideration of the foregoing the Sangguniang Bayan in session RESOLVED to authorize and approve the transfer of the franchise to operate cockpit in the municipality from Mr. Constante Dancel Sr. to Mr. Constante Dancel, Jr.

RESOLVED FURTHER to transcribe a copy of this resolution and furnish same to the Local Chief Executive for his appropriate action.


On motion of Member Domingo C. Ambrocio, Jr., duly seconded, the foregoing resolution was approved.
