WHEREAS, on the other hand, the National Historical Commission of the Philippines supports the municipality's declaration (MO#2016-11) which states that, "San Nicolas, formerly known as Caluntian, was established in 1584 as a visita of Laoag. Caluntian was converted into a municipality under the patronage of Saint Nicholas after it was separated from Laoag in 1617 as mentioned in the *Libro de Gobierno de la Provincia de Smo. Nombre de Jesus de Filipinas*, which could be found at the Archivo Augustiniano in Valladolid Spain. This claim is supported by Fr. Julian Martin in his *Mapa General De Las Almas Que Administran Los Pp. Agustinos En Estas Islas Filipinas* (1848); and by Agustin de la Cavada in *Historica Geografica, Geologica y Estadistica de Filipinas, Tomo 1* (1876)";

WHEREAS, it is imperative to recognize and acknowledge the significant role and contributions of various stakeholders in the culmination and celebration of the municipality's quadricentennial anniversary and Damili Festival 2018 which led to the conservation and promotion of San Nicolas' sense of historical identity;


