**“RESOLUTION NO. 2019-55**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALFREDO P. VALDEZ, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) REPRESENTED BY ITS EXECUTIVE DIRECTOR, RICO S. PABLEO, JR. FOR THE SECOND AMENDMENT OF THE PROJECT TITLED, “TARIPON SAN NICOLAS, ILOCOS NORTE: ENHANCEMENT OF COMMUNITY CULTURAL CENTER”.**

**WHEREAS**, a Memorandum of Agreement was executed by the NCCA and the municipality for the implementation of the project entitled, “Taripon San Nicolas, Ilocos Norte: Enhancement of Community Cultural Center” and it was duly notarized on February 08, 2017 at the City of Manila;

**WHEREAS**, Number 5 of the Memorandum of Agreement stated that “This Agreement shall take effect on February 1, 2016 and shall continue to be in force until February 28, 2017, after such time the municipality shall have been completed with all the terms and conditions satisfied;

**WHEREAS**, that the NCCA and the municipality agreed to amend the said Memorandum of Agreement and executive an Amendment to the Memorandum of Agreement dated June 11, 2018 extending the effectivity of the Memorandum of Agreement until October 31, 2018;

**WHEREAS**, the municipality wrote a letter requesting for another extension of the Memorandum of Agreement;

**WHEREAS**, that the NCCA and the municipality agreed to amend the number 5 of the said Memorandum of Agreement to be read as follows “This Agreement shall take effect on February 1, 2016 and shall continue to be in force until February 28, 2019;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.  
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, Hon. Alfredo P. Valdez, Jr. to enter into a Memorandum of Agreement (MOA) with the National Commission for Culture and the Arts (NCCA) represented by its Executive Director, Rico S. Pableo, Jr. for the second amendment of the project titled, “Taripon San Nicolas, Ilocos Norte: Enhancement of Community Cultural Center”.

**RESOLVED, FURTHER**, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


