“RESOLUTION NO. 2019-56

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALFREDO P. VALDEZ, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) REPRESENTED BY ITS GENERAL MANAGER, ALEXANDER F. BALUTAN ON THE SHARE OF THE MUNICIPALITY IN THE IMPLEMENTATION OF THE SMALL TOWN LOTTERY (STL).

WHEREAS, the PCSO under the Office of the President, is the principal government agency for raising and providing funds for health programs, medical assistance and services and charities of national character through the conduct of sweepstakes races, lotteries and other similar activities;

WHEREAS, the LGU is recognized as a vital instrument in providing the needed basic medical services to its constituents;

WHEREAS, in pursuit of its mandate and directives of the President of the Philippines, the PCSO is committed to raise revenues for the government through the Small Town Lottery (STL).

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.

– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, Hon. Alfredo P. Valdez, Jr. to enter into a Memorandum of Agreement (MOA) with the Philippine Charity Sweepstakes Office (PCSO) Represented by its General Manager, Alexander F. Balutan on the Share of the Municipality in the Implementation of the Small Town Lottery (STL).

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, foregoing resolution was unanimously approved.
