“RESOLUTION NO. 2019-82

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALFREDO P. VALDEZ, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE I AND THE AGRICULTURE AND FISHERY COUNCIL FOR THE IMPROVEMENT OF CATUGUING SMALL WATER IMPOUNDING PROJECT LOCATED AT BRGY. 22, SAN GUILLERMO UNDER THE SMALL SCALE IRRIGATION PROJECTS OF THE DEPARTMENT OF AGRICULTURE.

WHEREAS, the Department of Agriculture (DA) promotes agricultural development through a bottom-up self-reliant farm systems approach that will emphasize social justice, equity, productivity, and sustainability in the use of agricultural resources;

WHEREAS, the construction of Small Scale Irrigation Projects (SSIPs) will surely cause agricultural development and increase production;

WHEREAS, the Local Government Code of 1991 encourages complementation in the implementation of government projects between the local government and the national government through cooperation in the use of resources such as funds, facilities and services;

WHEREAS, the improvement of Catuguing Small Water Impounding Project located at Brgy. San Guillermo, San Nicolas, Ilocos Norte, is a vital project for agricultural development and production having an effective area of around 70 hectares;

WHEREAS, cognizant of the AFC's potential as partners in development that would provide private sector views and inputs, the Secretary of the Department of Agriculture (DA) issued Special Order No. 542, Series of 2007 authorizing the “AFC” to monitor and validate DA programs and projects;

WHEREAS, the Municipal Government of San Nicolas, Ilocos Norte DA RFO-I and the DA-CO agreed to cooperate and jointly implement the above cited project;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, Hon. Alfredo P. Valdez, Jr. to enter into a Memorandum of Agreement (MOA) with the Department of Agriculture Regional Field Office I and the Agriculture and Fishery Council for the Improvement of Catuguing Small Water Impounding Project located at Brgy. 22, San Guillermo under the Small Scale Irrigation Projects of the Department of Agriculture.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Ariel B. Villa, duly seconded, foregoing resolution was unanimously approved.
