“MUNICIPAL ORDINANCE NO. 2019-08

AN ORDINANCE IMPOSING FINES TO BUSINESS ESTABLISHMENTS WHO FAIL TO CLAIM THEIR BUSINESS PERMIT.

WHEREAS, as per record of the BPLO, a considerable number of business establishments doing business in the municipality fail to claim their business permits within the year of operation;

WHEREAS, the Business Permit is the best proof that an entity is conducting a legitimate business or merchandising, hence it is imperative that the business entity should secure and possess the same;

WHEREAS, the Revenue Code provides that failure to obtain the Business Permit will be penalized by a fine of P1,000.00; This though runs afoul to the intent of the Code that every entity should secure the necessary permit before doing business in the municipality;

WHEREFORE, *Be it Ordained by the Sangguniang Bayan of San Nicolas, Ilocos Norte in session duly assembled, that:*

SECTION 1. Short Title. This ordinance shall be known as **“An ordinance penalizing business establishments who fail to claim their Business Permits”**.

SECTION 2. Penal Clause. Business establishments which fail to claim their business permits shall be charged with the following fines;

- First Offense ----- P1,500.00
- Second Offense ----- P2,000.00
- Third Offense ----- P 2,500.00

SECTION 3. Separability Clause - If, for any reason any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. Repealing Clause. - Any ordinance, order, memorandum, rule and regulation which is inconsistent with the provisions of this Ordinance is hereby modified or repealed accordingly.


SECTION 5. Effectivity. – This Ordinance shall take effect upon approval and fifteen (15) days after its publication in a newspaper of local general circulation.
