“RESOLUTION NO. 2019-105

“A RESOLUTION DESIGNATING THE SENIOR TOURISM OPERATIONS OFFICER OF THE MUNICIPAL GOVERNMENT OF SAN NICOLAS, ILOCOS NORTE AS THE OFFICIAL SUBMITTER OF CULTURAL INVENTORIES OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE TO THE APPROPRIATE OFFICE OF THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) OR PERTINENT INSTITUTIONS OR AGENCIES.

WHEREAS, in 2014, the Municipal Government of San Nicolas, Ilocos Norte in partnership with the University of Sto. Tomas Graduate School Center for Conservation of Cultural Properties and Environment in the Tropics (UST-GS CCCPET), Department of Tourism (DOT), Department of Education (Dep.Ed), and Liga ng mga Barangay conducted cultural heritage mapping in the municipality resulting in a seven (7) volumes of identified and documented natural, built, intangible, and movable heritages abound in the locality;

WHEREAS, Municipal Ordinance No. 2018-18 also known as the “Damili Cultural Heritage Conservation Code” establishes the San Nicolas Registry of Cultural Property, Documentation and Preservation of Traditional and Contemporary Arts, and Institutionalization for the Conduct of Cultural Heritage Mapping;

WHEREAS, Republic Act No. 10066 also known as the “National Cultural Heritage Act of 2009” requires local government units to furnish copy of cultural inventory to the National Commission for Cultural and the Arts (NCCA);

WHEREAS, the municipal government has already submitted list of inventoried cultural properties to the NCCA but there is a need to update the same in light of the rich and diverse resources of cultural properties abound in the municipality;

WHEREAS, to conveniently, effectively, and efficiently carry out the intent of RA No. 10066, the National Commission for Culture and the Arts has, in a series of seminars or dialogue in relation thereto, required local government units to identify the office or person and designate as such as the official submitter of and focal person on the inventory of cultural properties with the Commission and other pertinent institutions or agencies;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to designate the Senior Tourism Operations Officer of the Municipal Government of San Nicolas, Ilocos Norte as the Official Submitter of Cultural Inventories of the Municipality of San Nicolas, Ilocos Norte to the Appropriate Office of the National Commission for Culture and the Arts (NCCA) or Pertinent Institutions or Agencies;

RESOLVED, FURTHER, that Mr. Richie Gielbys B. Cavinta, Senior Tourism Operations Officer of the Municipal Government of San Nicolas, Ilocos Norte, is hereby designated as the official submitter for the purpose;

FURTHERMORE, that the designation may be amended, modified, or revoked if necessary or on just grounds;

RESOLVED, FINALLY, to furnish copy of this Resolution to the Office of Philippine Registry of Cultural Properties of the National Commission for Culture and the Arts, the Commission, and all concerned, for their compliance, information, and guidance.


On motion of Member Norberto S. Dadiz, Jr., duly seconded, the foregoing resolution was unanimously approved.


