A RESOLUTION REQUESTING THE COMELEC FOR EXEMPTION FROM THE PROHIBITION OF HIRING PERSONNEL OF THE LOCAL GOVERNMENT UNIT, SPECIFICALLY THE DRIVER OF THE AMBULANCE STATIONED AT THE MUNICIPAL HEALTH OFFICE.

WHEREAS, the municipality is in dire need of a driver for the ambulance stationed at the Municipal Health Office;

WHEREAS, the COMELEC has issued guidelines, rules, and regulations, including the prohibited acts during the election period scheduled on May 13, 2019. Included in the prohibited acts is the hiring of additional personnel of the Local Government Unit (LGU);

WHEREAS, one of the basic needs of the people is their health needs especially in times of emergency, and thus it is imperative for the LGU to hire a driver to man the ambulance;

WHEREAS, there is a need to seek exemption from the COMELEC on the prohibition of hiring additional personnel, thus it was;

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan in session to seek exemption from the Commission on Elections on the hiring of a driver of the ambulance stationed at the Municipal Health Office;

RESOLVED FURTHER to transcribe a copy of this resolution and furnish same to the Local Chief Executive for his information and appropriate action.


On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, foregoing resolution was unanimously approved.
