“RESOLUTION NO. 2019-109

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALFREDO P. VALDEZ, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE CATUGUING MULTI-PURPOSE COOPERATIVE IN THE PROVISION OF FINANCIAL ASSISTANCE FOR THEIR RICE PROCESSING CENTER.

WHEREAS, the “LGU – San Nicolas” is primarily tasked, by virtue of existing laws of the land, to assist and/or support various qualified farmer organizations in establishing various projects and programs geared towards agricultural development;

WHEREAS, the “LGU – San Nicolas” allocates funds to aid/assist various farmer organizations through Financial Assistance, by virtue of the project/program entitled, “Aid to Associations”, to engage in various projects and programs geared towards agricultural development;

WHEREAS, the “Farmer Organization” is of good standing and a duly registered Farmers’ Organization under the Cooperative Development Authority (CDA) and accredited as Rural Based Organization (RBO) by the LGU – San Nicolas;

WHEREAS, the “Farmer Organization” is a recipient of Rice Processing Center I (RPC I) Project from Department of Agriculture - Regional Field Office I;

WHEREAS, the “Farmer Organization” has the capability and competence to engage in palay/rice trading and other rice-related and postharvest enterprise activities;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, Hon. Alfredo P. Valdez, Jr. to enter into a Memorandum of Agreement (MOA) with the Catuguing Multi-Purpose Cooperative in the Provision of Financial Assistance for their Rice Processing Center.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, foregoing resolution was unanimously approved.


