### **“RESOLUTION NO. 2019-118**

#### **A RESOLUTION APPROVING AND AUTHORIZING THE PURCHASE OF A SERVICE VEHICLE OF THE SAN NICOLAS POLICE STATION TO BE USED IN THE MUNICIPALITY'S PEACE AND ORDER PROGRAM.**

**WHEREAS**, Section 444 of the Local Government Code of 1991 provides enveloping powers of the Local Chief Executive to give essence to Section 16 of the same Code, otherwise known as the general welfare clause;

**WHEREAS**, in order to sustain the increasing services and development of the town, there is a need to purchase an additional vehicle of the San Nicolas Police Station to efficiently address the maintenance of peace and order program of the LGU;

**WHEREAS**, the funds needed for the purchase of said vehicle was duly appropriated by the Sangguniang Bayan and incorporated in the 2019 Annual Investment Plan as certified by the Municipal Budget Officer;

**WHEREAS**, purchase of government vehicles is now governed by rules set forth by concerned agencies, and this authority and approval by the Sangguniang Bayan is needed. Such acquisition shall be further subject to the provisions of Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act”;

**WHEREFORE**, be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session to authorize and approve the purchase of the LGU of a service vehicle to be used at the San Nicolas PNP Station;

**RESOLVED FURTHER** to transcribe copies of this resolution and furnish same to all concerned offices for their information and appropriate action.
